

THE JOHNSONVILLE BEST OF THE BACKYARD SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Johnsonville Best of the Backyard Sweepstakes ("Sweepstakes") is sponsored by Johnsonville, LLC ("Sponsor"), N6928 Johnsonville Way, Sheboygan Falls, WI 53085 and is administered by Prize Logic, LLC, ("Administrator"), Two Towne Square, Suite 200, Southfield, MI 48075.

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on August 29, 2022 at 12:00 PM Eastern Time ("ET") and ends on September 30, 2022 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes official clock.
- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees of Sponsor, Administrator, Bush Brothers and Company, Pit Boss Grills, a division of Dansons Inc., The Kingsford Products Company, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes. For purposes of the Sweepstakes, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

- 3. HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant must visit <https://thebestofthebackyard.com> ("Website") and complete and submit the registration form, including, but not limited to: his/her first and complete last name (no initials), phone number, city, state, and agreement to these Official Rules. Entrant will receive one (1) entry into the Sweepstakes for registering for the Sweepstakes. Entrant may then follow the links and instructions to complete the following activities to earn Sweepstakes entries:
 - A. Opt-In To Receive Marketing E-Mails:** During registration, an eligible entrant may opt-in to receive marketing e-mails from Sponsor, Bush's Beans, Kingsford, and/or Pit Boss brands. Entrant will receive one (1) entry into the Sweepstakes for each brand (Sponsor, Bush's Beans, Kingsford, and/or Pit Boss) opt-in. Entrant may opt-out at any time. Limit: One (1) Sweepstakes entry for each respective marketing e-mail opt-in, up to four (4) total entries per person.
 - B. Watch a Video:** During the Sweepstakes Period, an eligible entrant may follow the links and instructions to watch a video. There will be two (2) total videos. Entrant will receive one (1) entry into the Sweepstakes for watching each video, up to two (2) entries per person into the Sweepstakes. Limit: An entrant may watch each video one (1) time. **Entrant must watch the entire video in order to receive an entry.**
 - C. Take A Profile Quiz:** During the Sweepstakes Period, an eligible entrant may follow the links and instructions on the Website to take a profile quiz. Upon completing the profile quiz, entrant

will receive one (1) entry into the Sweepstakes **Limit:** There is a limit of one (1) entry per person during the Sweepstakes Period for taking the profile quiz.

D. Upload A Receipt or Mail-In:

- i. **Upload A Receipt:** During the Sweepstakes Period, an eligible entrant may purchase a participating Bush's, Johnsonville, or Kingsford Charcoal product (see Appendix for participating products) online and/or at any participating retailer, ("Qualifying Purchase"), while supplies last. The entrant must then visit the Website and follow the on-screen prompts and upload a photograph of the original receipt showing the Qualifying Purchase. It is recommended that purchaser first print his/her name on the original register receipt; sign and date the receipt; and circle the qualifying product on the receipt before uploading the receipt. Upon approval of receipt, an entrant will receive three (3) Sweepstakes entries. There is a limit of one (1) receipt upload per day, up to three (3) total receipt uploads during the Sweepstakes Period. An entrant may not submit the same receipt more than one (1) time. The file must be in .JPEG, .JPG, .PNG, or .GIF format (no PDFs will be accepted) and may not exceed 10 MB. Receipts must be submitted by 11:59:59 PM ET on September 30, 2022 to be valid. It is strongly recommended that the entrant maintain possession of the original or photocopy. The entrant should not give a receipt to any store employee. Duplicated receipts will not be accepted. Receipts must be readable. Mechanical reproductions, altered receipts, or unreadable receipts will not be accepted. Receipts submitted in excess of the limits set forth herein will not be accepted.
- ii. **Mail-In Without Making a Purchase:** To earn a Sweepstakes entry without making a purchase, an entrant may hand-write his/her complete name (no initials), valid e-mail address, street address (P.O. Boxes not accepted), city, state, ZIP code, telephone number, date of birth (MM/DD/YYYY), on a 3½"x5" card ("Mail-In Entry") and mail it (in an outer mailing envelope) with sufficient postage to The Johnsonville Best of the Backyard Sweepstakes, PO Box 251328, West Bloomfield, MI 48325. Limit one (1) 3½"x5" card per outer envelope. Each Mail-In Entry is worth three (3) entries. An entrant may mail-in one (1) time per day up to three (3) times total during the Sweepstakes Period. Following this method of entry, an entrant will receive three (3) entries into the Sweepstakes.

All Mail-In Entries must be postmarked by September 30, 2022 and received by October 10, 2022. Mail-In Entries must be legibly hand-written. Mechanical reproductions, postage-due, and Mail-In Entries sent in excess of the entry limits set forth below will not be accepted. Mail-In Entries received without a verifiable and legible return address will be deemed incomplete and not valid entries.

Limit: Regardless of method of entry (Upload a Receipt or Mail-in Without a Purchase), an entrant will receive no more than nine (9) total entries per person during the Sweepstakes Period. A "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day during the Sweepstakes Period, except on August 29, 2022 when a day is defined as starting at 12:00 PM ET and ending at 11:59:59 PM ET.

RESTRICTIONS ON ENTRIES: If more than the stated number of entries are received from the same person, telephone number and/or e-mail address, the entries may, at the Sponsor's sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address

or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor's sole discretion, may be disqualified and not be eligible to win a prize. Subsequent attempts made by the same individual to submit multiple entries by using multiple or false contact information, accounts or otherwise may result in the entrant being disqualified. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. Entries that are in excess of the stated limits, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. Once completed, the entrant will receive a link to the Website, and may follow the steps noted above to enter the Sweepstakes. **An entrant cannot participate solely by scanning the QR code.**

4. **RANDOM DRAWING:** On or around October 11, 2022, the Administrator will randomly select one hundred (100) potential winners from all eligible entries received during the Sweepstakes Period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.
5. **PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:**
 - A. **Prizes (100):** Each prize includes a cornhole set, a custom Pit Boss grill, a one (1) year supply of Johnsonville Sausage awarded as twenty-four (24) coupons each good for a package of Bratwurst, Italian Sausage, or Smoked Cooked links products, a one (1) year supply of Kingsford Charcoal (awarded as three (3) in-store coupons each good for any participating Kingsford Charcoal product and a \$10 Visa Gift Card Visa® Gift Cards, terms and conditions may apply. For assistance with the Visa® Gift Cards, call 1-833-322-6760), and a one (1) year supply of Bush's Baked Beans awarded as twenty-four (24) coupons each good for one (1) free Bush's Baked Beans product (each a "Prize"). No more than one hundred (100) Prizes will be available in the Sweepstakes. The ARV of each Prize is \$1,743.76.
 - B. **Total ARV:** The total ARV of all Prizes is \$174,376.
 - C. **Odds of Winning:** The odds of winning a Prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period.
 - D. **General Conditions:** There is a limit of one (1) Prize per person. Prizes that include coupons will be sent in multiple shipments. In no event will more one hundred (100) Prizes be awarded. Each potential winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or the Prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Failure to provide all required information and a signature on the documents within the stated time period may result in forfeiture of a winner's right to claim his/her Prize, and may result in the Prize being awarded to an alternate winner, if time permits. Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. Prizes are non-transferable and no prize substitution, exchange or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute a Prize of equal or greater value in case of unavailability of the Prize or force majeure, at Sponsor's sole and absolute discretion. If, for any reason, the Sweepstakes is not capable of running as planned, Sponsor reserves the right, at its sole and absolute discretion, to cancel, terminate, modify or suspend the Sweepstakes and/or proceed with the Sweepstakes, including the selection of a winner in a manner it deems fair and reasonable, including the selection of a winner from among eligible entries received prior to such cancellation, termination, modification or suspension. In no event will more Prizes be awarded than are stated in these Official Rules. In the event that, due to technical, typographical, mechanical, administrative, printing, production, computer or other errors, there are more winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winner.

IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS**

AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
